Fernandez: Welcomed all present and reminded them of the DEC Mission: Members represent Distance Education and follow Appendix G—(Union Contract) – used as guide to follow in presenting distance education for CSU. Work to ensure there is an effort to maintain standards and quality -- Over the past several years DEC implemented OCT – (Online Certification Training). CTRE also has an advanced course. We implemented an approval process whereby faculty demonstrate their mastery of being able to offer the course via the best online methods. We use ION (Illinois Online Network) rubrics to evaluate distance education offerings. The DEC meets every 3rd Tuesday of the month (intro repeated from Sept. meeting).

III. Reports

A. IBHE and SARA membership

Our Dec programs have been approved to joined Sara (the reciprocity agreement with other states online DEC programs). The fee is \$1750 annually. This is for membership in the Illinois Sara (Midwest Sara Ill, Ind. Mich. Wisc. MN). We must also apply for membership in the National-wide agreement as well. That cost is 4000 annually. A petition to find that \$\$ has been submitted to the Provost. The \$50.00 per student online fee we charge should cover part of these membership costs. We also need to create an online Institutional Complaint System which must be readily accessible from the Website

Requirement of SARA: We must demonstrate that our institution is offering "quality online programs -- DEC Approval can be used as a proof. Another CSU proof of quality is that we evaluate our online course offerings using the ION rubric. (Nationally approved assessment tool for evaluating courses).

B. Moodle Updates

Theo Garth reported on Big Blue Button, which began on Sept. 24th allowing for set up of video sessions in Moodle. Recorded videos can be retrieved & are in full production. Tutorials in Instructor Resource for Blue Button—plus a QuickStart guide (with video tutorials) are available on the website. Garth was still working with Banner to add/remove students in Moodle based on their enrollment status.

C. SLATE Conference

Sukowski report that the 13th annual Slate conf. is being held Oct. 21 - 23 Wed – Friday. Sic CSU staff or faculty are presenting or attending. Dr. Goins, Fernandez, Sukowsk will serve on 5 panels to assess online teaching & learning. Ms. Tenell Edinburgh will also be presenting.
