VI. Performance Based Funding Report

Searcy invite Dr. Watson to speak on the subject of Performance Based Funding.

Dr. Watson: Bullet points from his explanation.

- The PBF committee has completed its work for the legislature.
- The State of Illinois legislature will be making the decisions at this point. (It is being fast-tracked.
- The legislatures passed a bill that we have to move to performance funding based on key

metrics by 2013.

- One of the key metrics is the graduation rate. A possible goal proposed is three-times the national average.
- The committee, which Dr. Watson was a memember of have come up with a number of metrics which will be proposed at the IBHE meetings. They moved the metric from the graduation rate (ours is 14%) to the graduation number. We graduate 1,000 students a year. However, they were not proposing to count transfer students. Every year all public universities in the State of Illinois will be expect to increase the number of graduates.
- Due to differing missions, CSU committee members pushed to count students at different weight levels. Additional weight is proposed to be given for a variety of categories including African-American male, and the first member of a family to earn a bachelor's degree, and coming from the lowest economical quartile. An additional .4 will be added for each category. So, an African-American male from the lowest quartile who is the first in the family to earn a degree would earn 2.2. Based upon our mission, we could get 2 for every student we graduate.

There was a question and answer period regarding Performance Based Funding among Dr. Watson and members of Faculty Senate.

Searcy: Invited comment by Westbrooks on enrollment.

We are hoping to pick up those additional students. Sometimes it is not about the registration, but financial concerns. Some students have not validated. The Fall of 2011 we dismissed over 200 students. At the end of December of 2012, we dismissed approximately 260 students, and put on probation 300+ students. Last Saturday we opened registration for the first time in recent history, over 600 students registered. Registration will go through Wednesday evening until 7:00pm.
