# b. Emergency Roof Replacement & Building Envelope Repairs

Mrs. Monique Horton presented the resolution for emergency funding to repair the roof and building envelope of Douglas Hall. Mrs. Horton stated that the Capital Development Board (CDB) has agreed to grant the University \$4 million to complete the repairs. *Trustee Hill asked if that was the total amount needed.* Mrs. Horton replied yes.

Trustee Hill moved to approve the emergency roof replacement and building envelope repairs funded and administered by the CDB. Trustee James seconded the motion. The motion passed as follows:

## 5. Facilities Update

Mr. Michael Orr summarized the facilities capital development projects as follows:

• The miscellaneous library and water infiltration repairs have started.

- The emergency roof replacements for Education and O&M buildings will begin in July.
- The elevators in the Cook Administration, Education, BHS, William Science and Harold Washington buildings will be reconstructed from the shaft to the car.
- The William Science Center laboratory renovation project will be completed August 15.
- The Aquaponics project is complete. An open house is scheduled sometime in August.

Mr. Orr informed the Board that the reconstruction to the CTA turnaround project would consist of new curbs, new sidewalks, extensions of sidewalks, repaving and an upgrade for the relief station. He stated that the project was scheduled from July 15 – August 15.

Trustee Hill requested an update on the College of Pharmacy renovation.

Mrs. Horton responded that contracts have gone out for the architects to proceed with the three laboratories. *Trustee Hill asked about the cost of the labs*. She replied that the cost would be \$750,000 plus \$55,000 for the architect's fee. Mrs. Horton mentioned that an additional \$9.5 million is needed to complete the build out of the third floor. She also pointed out that this phase of the project is crucial to the final portion of the College's accreditation.
