1. Call to Order

Trustee Morrison Butler called the meeting to order.

2. Roll Call

4. Action Item

a. Approval of Previous Meeting Minutes

5. Information Items

a. Legislative Update

Dr. Erma Brooks Williams reported that the Illinois General Assembly adjourned on May 28. She stated that the State deficit is still \$13 billion. With respect to higher education, the universities were given authority to borrow monies under SB642. Dr. Williams mentioned that CSU is working with the federal governmental affairs staff to bring in more appropriations.

Dr. Williams reported that on September 10, U.S. Senator Roland Burris would like to host a special reception by bringing corporate sponsors and some governmental agencies to CSU to expose approximately 50 students to possible opportunities. Dr. Williams also reported that the National Conference of Black State Legislators (NBCSL) is considering having a social event at CSU next year.

Trustee Samuels queried about the status of the Westside campus. Dr. Wayne Watson stated that the governor's office is prepared to release a \$4 million planning grant. Dr. Watson explained that the Westside campus was in the planning process and that the Board, students, faculty, community and surrounding communities, along with everyone concerned, will participate.

b. Personnel Update

Dr. Renee Mitchell reported that her office has been working on the following three projects:

- 1. PeopleAdmin is software that will allow electronic applicant tracking. It will also maintain job descriptions as well as performance evaluations.
- 2. Web-Time Entry will allow employees to submit time cards electronically.
- 3. Direct Deposit initiative will reduce the amount of checks and direct deposit statements being printed each pay period.

Dr. Mitchell stated that these projects would eliminate paper and manual processes.

6. Other Matters

a. Public and Employee Comments
There were no public and employee comments.

7. Adjournment

Trustee James moved to adjourn the meeting. Trustee Rozier seconded the motion. The motion passed as follows:
