b. FY2012 Operating Budget

Mr. Meeks presented the \$123,812,000 revised FY2012 Operating Budget, detailing the appropriated and non-appropriated funds in the Internal Operating Budget. Mr. Meeks reported that the State has paid over \$8 million since the last meeting and noted that the State still owes the University \$13 million from FY2011.

Trustee Finney moved to approve FY2012 Operating Budget as proposed. Trustee Hill seconded the motion. The motion passed as follows:

c. The Center for STEM Education & Research

Dr. Yvonne Harris explained that CSU has received this grant from the U. S. Department of Education under the Predominately Black Institutions Competitive Grant Program. The total grant is \$2.4 million over a four year period, receiving \$600,000 per year. The purpose of the grant is to connect existing science, technology, engineering and mathematics (STEM) programs.

Trustee Hill moved to approve the STEM Education & Research grant. Trustee Samuels seconded the motion. The motion passed as follows:

d. Predominately Black Institutions Program - Formula Grants

Dr. Yvonne Harris explained that CSU has received this grant from the U. S. Department of Education under the Predominately Black Institutions Competitive Grant Program, the total grant is \$1.25 million over a five year period, receiving \$250,000 a year. The purpose of the grant is to create the center for Urban Agriculture, Ecology, and Alternative Energy.

Trustee Hill moved to approve the Predominately Black Institutions Program – Formula Grants. Trustee Scott seconded the motion. The motion passed as follows:
