# a. 1st Reading – Board of Trustees Regulations Sections 4, 5, 6, and 7

Ms. Marsh explained the amendment to the Board Regulations.

Ms Marsh stated that changes were made to sections 4 through 7 in an effort to merge the board regulations and the board policies into a single document titled the Governing Board Regulations and Procedures. Merging these documents eliminates redundancies as well as conflicts.

Section 4 of the Board Regulations and Procedures focuses on students, which now includes new provisions, including topics such as student discipline, student privacy and HIPAA.

Section 5, which centers on administrative affairs, was amended to include new provisions related to the budget committee and the President's authority to delegate signature authority to another administrative employee.

Section 6, which discussed physical facilities and Section 7, which is a board policy on HIPAA were amended to clean up language for purposes of clarifying and continuity.

The Board will be looking to vote all the regulations into approval at the December Meeting.

Trustee Buckner moved to approve the 1<sup>st</sup> Reading – Board of Trustees Regulations Sections 4, 5, 6, and 7. Trustee Gowen seconded the motion. The motion passed as follows:
