7. **Board Reports**

Academic Affairs

Chair Zopp called on Dr. Leslie Roundtree, Interim Provost, to give the Academic Affairs report.

Dr. Roundtree presented on the success of the summer camps. There are 8 students studying abroad and she hopes to expand that program. There are 10 new faculty members. Dr. Roundtree highlighted different grants and accomplishments made by the faculty. Dr. Roundtree also talked about two upcoming partnerships with the City Colleges of Chicago.

Graduate School Enrollment Update

Chair Zopp then asked Dr. V. Potluri to present an update on the Graduate School Enrollment. Dr. Potluri mentioned that domestic graduate students were down, but International students made up for the decline. Doctoral students also saw a slight decline. Dr. Potluri was excited that the Graduate School is now able to give scholarships to returning students. Each scholarship will be \$1000.

Student Trustee Report

Chair Zopp then called on Student Trustee James Elam for his report. Trustee Elam is excited to be the new Student Trustee. He also wants to encourage students to attend the Board Meetings and if they need help to use the services that Chicago State University provides.

Enrollment Management Report

Chair Zopp asked Oscar Rodriguez, Vice President Enrollment Management to present the Enrollment Report. Mr. Rodriguez gave the current enrollment numbers for Fall 2023. First year freshmen increased 21%, and transfer increased 23%. Mr. Rodriguez also gave the profiles of the Fall 2023 undergraduate entering class. Mr. Rodriguez then gave an update on administrative projects. Admissions is on boarding a new lead generation partner and extending the contract for the Admissions marketing partner. Finally, Mr. Rodriguez gave the status of applications. There are 372 first year freshman applications, transfer will open on October 1st. The office of admissions has participated in 86 college fairs and 67 high school visits as of September 8, 2023.

Finance and Audit Report

As Chair of the Finance and Audit Committee, Chair David called on Nicole Latimer Williams, Chief Financial Officer, and Vice President of Financial Operations to present three resolutions.

Dr. Carroll presented on the Sports Expansion. She gave the timeline and thanked the Exploratory Committee for their work. The exploratory committee unanimously agreed to recommend the formation of Football Championship Subdivision (FCS) Football, women's swimming, and women's triathlon at Chicago State University. She went over various highlights from the recommendation and fundraising projections. She stated that after approval from the board women's triathlon will be added in Fall 2024 and she would like to announce the public fundraising campaign for sports expansion,
