Federal Register

The *Federal Register* is the official daily publication for Rules, Proposed Rules, and Notices of Federal agencies and organizations, as well as Executive Orders and other Presidential Documents. This site provides access to the entire Federal Register.

Federal Register Environmental Subset

Full text of all Federal Register documents issued by EPA, and of selected documents issued by other Departments and Agencies. Notices, meetings, proposed rules, and regulations are divided into twelve topical categories for easy access (eg. air, water, pesticides, toxics, waste).

EPA Semiannual Regulatory Agenda

All agencies publish semiannual regulatory agendas describing regulatory actions they are developing or have recently completed. These agendas are published in the Federal Register, usually during the spring and fall of each year, as part of the Unified Agenda of Federal Regulatory and Deregulatory Actions.

EPA Dockets

Dockets contain information and supporting documentation related to the rulemaking process. Public comments received on rules and proposed rules are also maintained in the appropriate Docket.

Code of Federal Regulations

The Code of Federal Regulations (CFR) is a codification of the rules published in the Federal Register by Executive departments and agencies of the Federal Government. The CFR is divided into 50 titles, which represent broad areas subject to Federal regulation, with environmental regulations contained mainly in title 40. Each volume of the CFR is revised once each calendar year. Title 40 is revised every July 1.

Environmental Impact Statements

Search for EIS's in the catalog by doing a Guided Keyword search using the term "EIS" in conjunction with any other keyword(s). EIS's are documents required of federal agencies by the National Environmental Policy Act for major projects or legislative proposals significantly affecting the environment. A tool for decision making, they describe the positive and negative effects of the undertaking and cites alternative actions.

Databases

Lexis-Nexis Congressional Universe

Subscription database containing regulations, laws, congressional testimony, bill histories, and pending legislation. Also provides full text access to articles that appeared in The Hill, Roll Call, or the Washington Post section A.

Books

There are many plain-English guides to specific laws and regulations. The U.S. Environmental Protection Agency is an excellent source of free information.
