ELIGIBILITY

- ◆OFFICIAL ADMISSION TO COLLEGE OF EDUCATION
- ◆PROOF OF PASSING SCORES ILLINOIS TESTS OF BASICS SKILLS AND CONTENT AREA TEST
- ◆GPA REQUIREMENTS- CHECK WITH DEPARTMENTS



ELIGIBILITY REQUIREMENTS

- ◆MINIMUM OF 100 PRE-CLINICAL CLOCK HOURS
- ◆CLEARED BACKGROUND CHECK
- ◆CURRENT TB TEST
- ◆APPLICATION SIGNED BY DEPARTMENT ADVISOR & CHAIRPERSON



PLACEMENT PROCEDURES

- ◆ALL PLACEMENTS ARE COORDINATED BY COFPS
- ◆GENERALLY PLACED WHERE STUDENTS HAVE COMPLETED INTERNSHIPS/
 METHODS FIELD EXPERIENCES
- ◆STUDENTS MUST NOT CONTACT
- ◆ SCHOOLS WITHOUT PRIOR APPROVAL FROM COFPS



PLACEMENT PROCEDURES

STUDENT TEACHERS ARE NOT ASSIGNED TO SCHOOLS:

- ◆ where they have worked.
- where any of their family members currently work.
- ◆ where their children currently attend.
- where you used to attend school.

OPTIONS PROGRAM: Full-Time

◆ Substitute Teachers who have been assigned to the school 3 years or more ~ teaching in their content area (See COFPS for application procedures).



ATTENDANCE

- ◆STUDENT TEACHERS MUST REMAIN IN SCHOOLS THE SAME NUMBER OF HOURS PER DAY REQUIRED OF TEACHERS INTHE SCHOOLS IN WHICH THEY ARE STUDENT TEACHING
- ◆THIS INCLUDES CONFERENCES AND OTHER ACTIVITIES RELATED TO STUDENT TEACHING
- ◆HOURS NOT SPENT IN TEACHING MUST BE SPENT ENGAGED IN SOME EDUCATIONALLY RELATED TASK



SUBSTITUTE TEACHING

- ◆STUDENT TEACHERS ARE NOT ALLOWED BY THE ILLINOIS STATE BOARD OF EDUCATION (ISBE) TO SERVE AS A SUBSTITUTE TEACHER DURING STUDENT TEACHING EXPERIENCE
- ◆EXCEPTIONS ARE MADE FOR STUDENTS ENROLLED IN OPTIONS PROGRAM



COURSE LOAD

- ♦ NO COURSES MAY BE TAKEN WITH STUDENT TEACHING WITHOUT PRIOR APPROVAL
- ◆ STUDENTS SEEKING PERMISSION MUST FIRST FILE A PETITION IN THE COLLEGE OF EDUCATION
- ◆ THE ADMISSIONS ANDSTANDARDS
 COMMITTEE WILL REVIEW THE PETITION.
 (ED 203) STUDENTS ARE THEREAFTER
 NOTIFIED OF THE COMMITTEE'S DECISION
 WHETHER A COURSE MAY BE TAKEN
 WHILE STUDENT TEACHING


