## April 2021

- April 19 ..... Priority Registration for Regular Session (16-weeks) and Special Session (12 weeks) begins.  
April 19 ..... Enrollment opens for payment plans. Please visit [Bursar's page for more information](#).

## May 2021

- May 1 – May 31 ..... Summer 2021 Registration continues (*Payment due **May 28<sup>th</sup>** or upon registration*).  
May 27 ..... **Summer 2021 registration will close and will resume Friday, May 28<sup>th</sup>**.  
May 28 ..... Verified Payment Source due (*This is how you plan to pay for tuition and fees for the semester. For questions, please email [bursar@csu.edu](mailto:bursar@csu.edu)*).  
May 28 ..... Payment **due in Full** (*all Summer sessions*).  
May 31 ..... **Memorial Day Holiday – NO CLASSES, CAMPUS HOLIDAY**.  
May 31 ..... **Last day** to register for classes beginning the **week of May 31** (*Payment due at time of registration*).

## June 2021

- June 1 ..... **1st five-week classes begin** (*June 1 – July 3*).  
June 1 ..... **10-week classes begin** (*June 1 – August 7*).  
June 1 - 2 ..... **Late Registration Period**. Students must email or submit an Add-Drop Form to the Office of the Registrar ([CSU-Registrar@csu.edu](mailto:CSU-Registrar@csu.edu) or ADM 128).  
June 3 ..... **Last day to drop a 1st five-week course** (*June 1 – July 3*) or submit a **Complete Withdrawal** request for 1<sup>st</sup> five-week coursework—located on the “student” tab of Cougar Connect—from all courses online for 100% reversal of tuition and refundable fees.  
June 4 ..... **First E-Bill posted for Summer 2021**. Subsequent E-Bills will be sent monthly.  
June 6 ..... **Last day to drop a ten-week course** (*June 1 – August 7*) or submit a **Complete Withdrawal** request for ten-week coursework—located on the “student” tab of Cougar Connect—from all courses online for 100% reversal of tuition and refundable fees.  
June 6 ..... Last day to **Completely Withdraw** from the **1<sup>st</sup> 5-week session** and receive a **50% reversal of tuition and fees** (*note: this only applies for Complete Withdrawals, not when dropping individual classes*).  
June 12 ..... Last day to **completely withdraw** from the **Summer (10-week) session** and receive a **50% reversal of tuition and fees** (*note: this only applies for Complete Withdrawals, not when dropping individual classes*).  
June 16 ..... **Holds** are placed on students' accounts for **Past Due Balances**.  
June 21 ..... **Last day to withdraw** from a **1st five-week course** or submit a **complete withdrawal** request from all **1st five-week courses** (*June 1 – July 3*) online with a grade of **W** on transcript. **Charges are not reversed**.  
June 25 ..... Deadline to submit a graduate graduation applications and GAPP form to Graduate and Professional Studies Office (*ADM 129*) for August 2021 degree conferment.  
June 25 ..... Deadline to submit an undergraduate graduation application online for August 2021 degree conferment.

## July 2021

- July 1 ..... **Summer 2021 registration will close and will resume Friday, July 2<sup>nd</sup>**.  
July 2 ..... Graduate Students: deadline to submit approved thesis/dissertation to ProQuest.  
July 3 ..... **Last day** of class for the **1st five-week** session.  
July 5 ..... Last day to register for classes starting the week of July 5<sup>th</sup>. Payment is due at time of registration.  
July 5 ..... **Independence Holiday (observed) – NO CLASSES, CAMPUS HOLIDAY**.  
July 6 ..... **2nd five-week classes begin** (*July 6 – August 7*).  
July 8 ..... **Last day** to drop a **2nd five-week course** (*July 6 – August 7*) or submit a **Complete Withdrawal**

request for 2<sup>nd</sup> five-week coursework—located on the “student” tab of Cougar Connect—from all courses online for 100% reversal of tuition and refundable fees.

- July 11..... Last day to **completely withdraw** from the **2<sup>nd</sup> 5-week session** and receive a **50% reversal of tuition and fees**. *Note: this only applies for Complete Withdrawals, not when dropping individual classes.)*
- July 12..... **Last day to withdraw** from a **Summer 10-week course** or submit a **complete withdrawal** request from all **10-week courses** (*June 1 – August 7*) online with a grade of **W** on the transcript. **Charges are not reversed** (*note: Students will not be able to drop the last class online after **May 22<sup>nd</sup>**. Students must complete and submit the **online** “Complete Withdrawal Form” located on the “Student” tab of Cougar Connect).*
- July 26..... **Last day to withdraw** from a **2nd five-week course** or submit a **complete withdrawal** request from all **2nd five-week courses** (*July 6 – August 7*) online with a grade of **W** on the transcript. **Charges are not reversed** (*note: Students will not be able to drop the last class online after **May 22<sup>nd</sup>**. Students must complete and submit the **online** “Complete Withdrawal Form” located on the “Student” tab of Cougar Connect).*

## August 2021

- August 7 ..... Summer 2021 classes end.
- August 10 ..... Summer 2021 Session ends.
- August 10 ..... **Faculty deadline** to submit final grades for Summer 2021 in Cougar Connect via CSU X-Press. Faculty must send completed form to [CSU-Registrar@csu.edu](mailto:CSU-Registrar@csu.edu).
- August 10 ..... **Faculty deadline** to submit an Incomplete contract "I grade" for Summer 2021. Faculty must send completed form to [CSU-Registrar@csu.edu](mailto:CSU-Registrar@csu.edu).
- After August 13 ..... Summer 2021 final grades are available in [CSU X-Press](#).
- After August 13 ..... Summer 2021 degree begin posting and will be available in [CSU X-Press](#).
