## April 2015

April 20 – June 1 .....Advance / Regular Registration for Summer 2015 (Validation / Initial Payment due May 11, 2015 or upon registration)  
April 27 – August 7 .....Advance Registration for Fall 2015

## May 2015

May 1 – June 2 .....Summer 2015 Registration continues (Validation / Initial Payment due May 11, 2015 or upon registration)  
May 11 .....Validation / Initial payment due or upon registration (All Summer Sessions)  
May 25 .....Memorial Day Holiday – No CLASSES  
May 26 .....Last day to register for classes beginning the week of May 26 (Validation / Payment due at time of registration)  
May 26 .....1st five-week classes begin (Classes meet May 26 – June 27)  
May 26 .....10-week classes begin (Classes meet May 26 – August 1)  
May 27 – June 29 .....Registration continues for classes starting the week of June 29 (Validation / Payment due at time of registration)

## June 2015

June 2 .....Last day to drop a ten-week course (Classes meet May 26 – August 1) with full reversal of charges.\*  
June 2 .....Last day to drop a 1st five-week course (Classes meet May 26 – June 27) with full reversal of charges.\*  
June 12 .....Last day to withdraw a 1st five-week course (Classes meet May 26 – June 27) with a grade of W on transcript.  
Charges are not reversed.  
June 18 .....Final payment due for 1st five-week course registration  
June 19 .....Deadline to submit approved graduate graduation applications to Graduate School evaluators (ADM 308)  
June 21 .....Deadline to submit approved undergraduate graduation applications to Office of Evaluations (ADM 128)  
June 27 .....Last day of class for the 1st five-week session  
June 29 .....Last day to register for classes starting the week of June 29 and later (Validation / Payment due at time of registration)  
June 29 .....Classes begin for the 2nd five-week session (Classes meet June 29 – August 1)

## July 2015

July 4 .....Independence Day Holiday – No CLASSES  
July 6 .....Last day to drop a 2nd five-week course (Classes meet June 29 – August 1) with full reversal (100%) of charges.\*  
July 16 .....Final payment due for ten-week and 2nd five-week sessions  
July 17 .....Last day to withdraw a 10-week course (Classes meet May 26 – August 1) with a grade of W on the transcript  
July 17 .....Last day to withdraw a 2nd five-week course (Classes meet June 29 – August 1) with a grade of W on the transcript

## August 2015

August 1 .....Summer 2015 Session ends  
August 4 .....Faculty deadline to submit final grades for Summer 2015  
August 4 .....Faculty deadline to submit an Incomplete contract "I grade" for Summer 2015  
After August 7 .....Summer 2015 final grades are available on CSU Express

\*NOTE: Students will not be able to drop the last class online resulting in a full withdrawal with zero (0) credit hours of enrollment after May 16, 2015. Students must request, complete and submit the online "Complete Withdrawal Form" via the web to the Office of the Registrar by the deadline date. He/she must also participate in a short exit interview with a financial aid advisor prior to the processing of the complete withdrawal by the Registrar's Office.
