

## 2019-2020 VERIFICATION OF PARENT ILLINOIS RESIDENCY

The Illinois Student Assistance Commission (ISAC) requires that in order for a dependent student to be eligible for the Monetary Award Program (MAP) the parent whose information is required to be included on the student's Free Application for Federal Student Aid (FAFSA) must be a resident of the State of Illinois. It is Chicago State University's responsibility to ensure that all MAP recipients meet this ISAC requirement. For a dependent student to be considered an Illinois resident: **the parent of the dependent student must physically reside in Illinois and Illinois must be his/her true, fixed, and permanent home.** Students who are in a graduate or post-baccalaureate program are not eligible for MAP.
