This form must be presented to the Office of Student Financial Aid once each academic year. **The Senior Citizen Tuition Waiver pays tuition only! The Waiver does not pay fees, books, parking, etc.** The Waiver can be used for students enrolled in Bachelors, Masters, Teacher Certification, Certificate, and Doctoral degree programs or in an "at-large" status program. The Senior Citizen Tuition Waiver is awarded to students who are accepted for admission, who are 65 years of age, or older, at the beginning of any semester, who are legal residents of Illinois, and who have an annual combined household income in 2022 at, or below, 200% of the 2022 Federal Poverty Level (based upon family size - see chart below).

- Annual combined household income in 2022 at or below 200% of the 2022 Federal Poverty Level.

Benefits of this waiver will not be posted to a student's account until all documentation is received, reviewed, and validated by the Office of Student Financial Aid.
